Brief summary of updates, decisions, and next steps

1. Timeline for upcoming CCC leading roles elections.

2. Updates from the Managing Director

- MD to go on paternity leave, notified the CCC of availability during this time.
- Vienna Hub announced vacancies for the MENA regional coordinator and Sub Saharan Africa regional coordinator positions.
- The Vienna Hub team and civil society colleagues are working on COSP proposals for resolutions that are being considered by governments.
- Consideration of ways to support delegates to travel to the COSP.
- The Vienna Hub is involved in several side events for the CoSP10.
- The MD reported on funding updates.

4. Updates from CCC members

 Several CCC Members are involved in drafting language for COSP resolutions in conversations with governments.

- Update on visa issues for civil society to attend the COSP10 in Atlanta.
- Co-Chair Gillian Dell announced the publication of a working paper by Transparency International on <u>Tackling Grand Corruption Impunity: Proposals</u> for a definition and <u>special measures</u> and the presentation session launching the report.
- CCC member Umar Yakubu announced the planning of, in collaboration with Vice Chair David Ugolor, a symposium with experts and academics presenting on Countering Organised Crime, including a thematic session on grand corruption and asset recovery. A letter is to be sent out on this to the MD with further details and to be circulated within the Coalition network.

5. Internal procedures

- The CCC adopted the Transparency Policy.
- The CCC adopted the Interest Disclosure Form.
- The CCC agreed to vote on the procedures for the Whistleblower and Anti-harassment policies via email in the coming weeks.
- The Vienna hub team presented new/updated internal policies to be voted on in the CCC October meeting.
- Aim to finalise the draft of comprehensive rules of procedure governing board decision-making and external communications, and the Whistleblower policy. The objective is to present the policies at the October CCC meeting.
