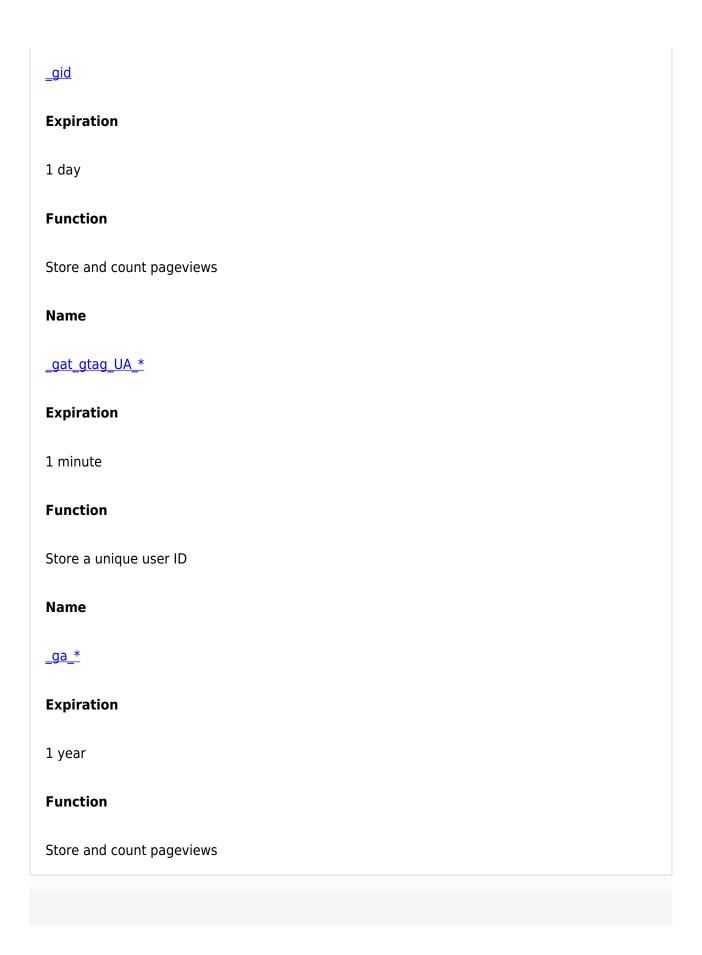
3. Placed cookies
